

# LITTLE DRUM

## *Landing*

### EVENT POLICIES

#### EVENT DURATION:

- The standard event duration is four (4) hours.

#### CATERING AND BEVERAGES:

- All food and beverage services will be provided by in-house teams: Elijah's Oyster & Fish Camp or The Pilot House.

#### VENUE ACCESS AND DECORATING:

- Operating hours: 11 AM - 10 PM Sunday - Thursday, and 11 AM - 11 PM Friday and Saturday.
- Guests may decorate and schedule vendor deliveries during operational hours, including up to one hour before the event's start time. Additional time may be available based on availability.
- Only individuals assisting with setup are allowed inside during preparation.

#### VENUE PROVISIONS:

- Dinner service includes china, chafing dishes, serving utensils, silverware, and glasses. Plates and flatware are provided for appetizers and cake.
- Guests are responsible for additional table decorations.
- Included rentals for events: tables, white padded resin chairs, white floor-length linens, and napkins.
- Additional items (e.g., tents, lights, specialty linens, heaters) are available for rent.

#### EVENT CONCLUSION:

- All events must conclude by 10 PM Sunday - Thursday and 11 PM Friday - Saturday unless prior arrangements are made.
- A 15-minute grace period is allowed for guest departure.
- Guests have one hour after the event to remove decorations and trash. Items left overnight must be collected the following morning by 11 AM.

#### DECORATING GUIDELINES:

- Prohibited items: artificial flower petals, glitter, confetti, rice, and poppers on the deck.
- Damages resulting from decorations or guest activities are the guests' responsibility.
- Wax spills on standard linens may incur a replacement fee.

#### FIRE SAFETY:

- Candles or flames must be pre-approved and contained in lanterns or approved holders.
- Sparklers require prior approval and proper safety measures.

#### REHEARSALS:

- Wedding rehearsals are offered based on availability and are free for one (1) hour.
- Rehearsals must conclude two (2) hours before any other scheduled event.

## LANDING

### VENDOR AND ENTERTAINMENT POLICIES:

- All outside vendors require prior approval.
- Amplified sound must end by 10 PM (Sunday - Thursday) and 11 PM (Friday - Saturday) in accordance with city ordinances.
- Equipment such as microphones or speakers is not provided.

### PARKING:

- Little Drum Landing has two parking lots available on a first-come, first-served basis, free of charge.

### GUEST CONDUCT:

- Guests must behave respectfully. Lewd behavior, drug use, and excessive noise are prohibited. Violations may result in removal and the immediate conclusion of the event.

### TENTS, LIABILITY, AND WEATHER:

- Little Drum Landing is not liable for guest injuries or inclement weather.
- While the outdoor space does not require a tent, it is recommended to rent one for added comfort and protection during inclement weather.
- Indoor capacity: 45 seated guests, 75 standing guests.
- In the event of inclement weather and if a tent is not rented, Little Drum Landing does not have an alternative indoor space available.
- Refunds will not be issued for inclement weather, but Little Drum Landing will gladly work with guests to reschedule the event based on availability.

### ALCOHOL POLICIES:

- All alcohol must be purchased through Little Drum Landing. No outside alcohol is allowed on the property.
- Only Little Drum Landing staff may serve alcohol.
- Alcohol is not allowed on the county-owned boardwalk, sidewalks, or adjacent walkways.
- Guests under 21 years of age will not be served alcohol.
- Last call is 15 minutes before the event ends.
- No martinis, keg beer, or frozen drinks are available.

### CANCELLATIONS:

- Cancellations require written notice at least fourteen (14) days before the event.
- Guests are responsible for costs incurred by Little Drum Landing if not canceled within this period.
- Any deposits paid will be forfeited.

### PAYMENT POLICIES:

- Accepted forms of payment: major credit cards, cash, certified checks, or corporate checks.
- A \$500 non-refundable retainer is required to secure a date on the Little Drum Landing calendar.
- This amount is applied to the final bill unless the event is canceled.

### FOOD AND BEVERAGE MINIMUMS:

- Each event has a tailored food and beverage minimum based on event details.
- All minimums are subject to a 20% gratuity and a 5% coordination fee.
